1. The Government of Assam after careful consideration has decided to establish "Kaziranga Tiger Conservation Foundation" under Section 38(X) of the Wildlife(Protection ) Act as amended up to date 2006 for tiger reserve within the State in order to facilitate and support their management for conservation of tiger and biodiversity and, to take initiatives in eco development by involvement of people in such development process and also for expeditious utilization of the funds released by the Government of India, as well as State Government
2. Government further, hereby, accord permission to use the name "Kaziranga Tiger Conservation Foundation" for registration under the Assam Societies Registration Act 1860.
3. The Memorandum of Association of the "Kaziranga Tiger Conservation Foundation" and Articles of Association are appended to this order.

4. The Principal Chief Conservator of Forests (Wildlife) and Chief Wildlife Warden, Assam is directed to take necessary further action for registration of the "Kaziranga Tiger Conservation Foundation" under the provisions of the Assam Societies Registration Act, 1860.
5. The Member Secretary of the Foundation will furnish guidelines for operating the funds and obtain approval of the State Government before operationalisation of the fund.


