**ORDER**



Pursuant to letter No. F.NO.3(1)-51/2005-PT, dated, 05-10-2006 and also to letter No.F.NO.15-1/2006, NTCA, dated, 05-01-2007 from the Member Secretary National Tiger Conservation Authority read with the objective indicated with Section 38(X)(2) of the Wildlife(Protection ) Act, 1972 as ammended in 2006(Act 39 of 2006):

1. The Government of Assam after careful consideration has decided to establish "Manas Tiger Conservation Foundation" under Section 38(X) of the Wildlife(Protection ) Act as amended up to date 2006 for tiger reserve within the State in order to facilitate and support their management for conservation of tiger and biodiversity and, to take initiatives in eco development by involvement of people in such development process and also for expeditious utilization of the funds released by the Government of India, as well as State Government.
2. Government further, hereby, accord permission to use the name "Manas Tiger Conservation Foundation" for registration under the Assam Societies Registration Act 1860.
3. The Memorandum of Association of the "Manas Tiger Conservation Foundation" and Articles of Association of the Foundation are appended to this order.

4. The Principal Chief Conservator of Forests (Wildlife) and Chief Wildlife Warden, Assam is directed to take necessary further action of registration of the "Manas Tiger Conservation of Foundation" under the provisions of the Assam Societies Registration Act, 1860.
5. The Member Secretary of the Foundation will furnish guidelines for operating the funds and obtain approval of the State Government before operationalisation of the fund.


